### Type

This product is an unsecured debt instrument governed by English law.

### Term

This product has a life span of 5 years but can be redeemed earlier according to the conditions indicated in the "objectives" section below.

### Objectives

This product is designed to provide a fixed coupon on a periodic basis during the product life time. It is possible for the product to be automatically redeemed early based on pre-defined conditions. The product provides full capital protection at maturity only.

#### Coupon

Provided that the product has not been previously redeemed early:  
On each Coupon Payment Date, you will receive the Coupon.

#### Automatic Early Redemption

On any Early Redemption Observation Date, if the level of the Reference Underlying is at or below the Early Redemption Barrier, the product will be redeemed early and you will receive, on the Early Redemption Payment Date, apart from the Coupon mentioned above:  
100% of the Nominal Value plus the Early Redemption Coupon.

#### Final Redemption

On the Maturity Date, provided that the product has not been redeemed early, you will receive, apart from the Coupon mentioned above, a final redemption amount.  
- If the Final Level of the Reference Underlying is at or below the Final Barrier, you will receive: 100% of the Nominal Value plus the Final Coupon  
- Otherwise, you will receive 100% of the Nominal Value.

#### Additional Information

- Coupons are expressed as a percentage of the Nominal Value.

**Intended Retail Investor**

The product is aimed at investors who:

- Have specific knowledge or experience of investing in similar products and in financial markets, and have the ability to understand the product and its risks and rewards.
- Seek a product offering income with full capital protection and have an investment horizon in line with to the recommended holding period stated below.

**WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?**

**Summary Risk Indicator**

The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 1 out of 7, which is the lowest risk class.

This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact our capacity to pay you.

You are entitled to receive back at least 100% of your capital (where "capital" means Nominal Value and not invested amount). Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash in before the Maturity Date.

If we are not able to pay you what is owed, you could lose your entire investment.

Inflation Risk : if the current economic situation characterized by high inflation persisted throughout the life time of the product, then the "real" return of the product, equal to its return minus the inflation rate, might be negative.

## WHAT ARE THE COSTS?

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

The duration of this product is uncertain as it may terminate at different times depending on how the market evolves. ## HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

**Recommended Holding Period: 5 years, which corresponds to the product maturity.**

Under normal market conditions, Société Générale or an entity of its group ensures a daily secondary market during the life of the product by providing bid and offer prices expressed as percentages of the nominal value and the difference between the bid and offer prices (the spread) will not be more than 1% of such nominal value. If you want to sell the product before the Maturity Date, the price of the product will depend on market parameters at the time you wish to sell and you may sustain a partial or total capital loss. In unusual market condition, the resale of the product may be temporarily or permanently suspended.
