The risk indicator assumes you keep the product until 17 February 2025. The actual risk can vary significantly if you cash in at an early stage and you may get back less. We have classified this product as 1 out of 7, which is the lowest risk class. This rates the potential losses from future performance of the **underlying** at a very low level and the potential for us to be unable to pay you any amounts due as very unlikely.

The favourable, moderate and unfavourable scenarios represent possible outcomes that have been calculated based on simulations using the reference asset's performance over up to 5 past years. 5. How long should I hold it and can I take money out early?

Recommended holding period: 1 year and 6 months
